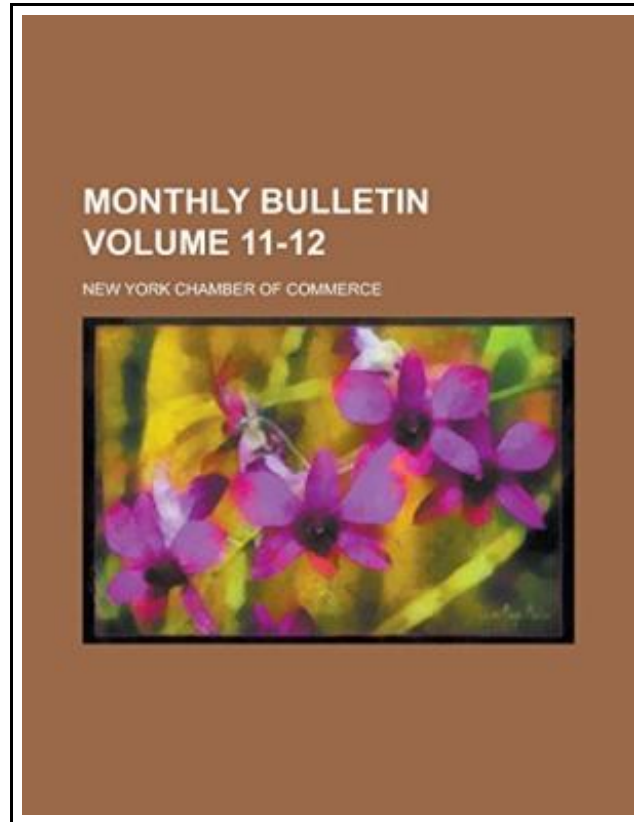

The New York Chamber has already expressed itself strongly upon the necessity of maintaining our position in foreign trade and of creating a permanent American merchant marine, and the attainment of these ends demands the free play of economic laws and competition in marine insurance, which is an important factor in these enterprises. At the monthly meeting last Thursday, the Chamber adopted a report pointing out the futility of certain State Government regulations in cases where economic boundaries and State boundaries are not coterminous. The same conditions apply to the marine insurance field, and it cannot be advantageously controlled by a single...
